

## Interim Review of the Island Plan 2011

### Further Examination in Public

This is a further note regarding the Interim Review of the Island Plan 2011. The Minister has lodged his intended Revised Plan with a view to debate by the States Assembly during week commencing 14th July 2014. In response, a number of other States Members have lodged proposed amendments.

At the request of the Minister, the Inspectors will be examining amendments 6, 9 and 10 during an Examination in Public (EiP) on 7 July and the participants listed below have been invited to take part. The programme for the day is also set out below. The format of the discussions will follow those of previous EiPs, in essence an opportunity for a range of informed viewpoints to be expressed and discussed.

Written representations already submitted will, of course, be taken fully into account, along with spoken views on the day. There is no requirement for any further written statements to be submitted. Please note that discussions will be limited to consideration of the listed amendments. Amendment 5 (relating to land at Plemont) has been withdrawn by its sponsor and will therefore not be considered. The Inspectors have not been asked by the Minister to consider amendment 9b or any of the remaining amendments, all of which relate to matters which they examined during the EiP in January and dealt with in their report. The Inspectors will submit their report in advance of the States debate the following week.

The Minister's submitted Revised Plan may be seen at States of Jersey consultation web site<sup>1</sup> and all the lodged amendments in full at the States Assembly web site<sup>2</sup>. The Minister will also publish, in advance of the EiP, his initial response to the amendments that have been lodged by States Members and the public comment that has been made on them: this will be available on the States of Jersey website referred to above at <sup>1</sup>.

If you have a query or comment on any aspect of this note, I would be grateful if you could let me know by no later than this Friday (6<sup>th</sup> June).
