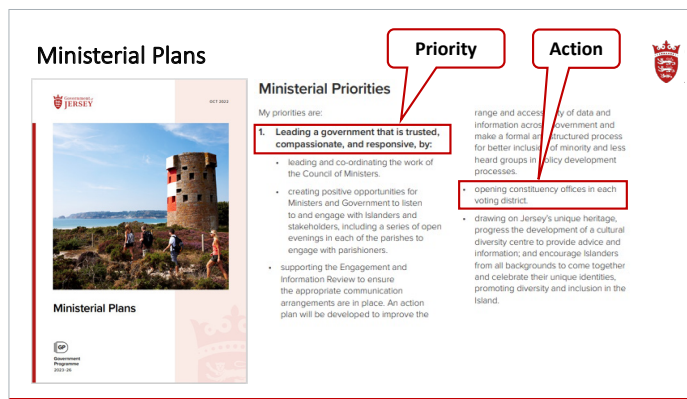
How to use the Delivery Plan tables
