#### Notes to Appendix 3:

- 1. Should you consider a site has not been listed above which was previously put forward in an initial representation, please contact the Programme Officer.
- 2. Please note the Inspectors are examining the Plan as prepared by the Government of Jersey. Therefore, they will in the first instance, be considering the merits for the development of sites included in the Plan ("allocated sites"). However, should they determine that there is a need for additional or different sites to be allocated, they will take account of the alternatives suggested by the Minister for the Environment, the sites proposed in public representations to the Plan and the States Members' suggested amendments.
- 3. Not all of the sites listed above will be the subject of discussion. The Inspectors will decide upon which sites they wish to receive oral submissions based upon those selected to participate at the relevant EiP session. The Inspectors will assess all other sites using the written representations which have been submitted. Written representations and oral submissions will carry equal weight.
