# Health Certificate to export rabbits and rodents to Europe

# Application for an official export certificate(s) for the non-commercial movement of pet rabbits and rodents to the European Union (EU), Switzerland and Norway.

National rules apply for the import of pet rabbits and rodents. Not all countries may require a pet to have an export health certificate ('EHC') to enter.

We recommend you contact an agency, or the ferry/airline operator to assist you with taking your pet rabbits and rodents away with you. For pets entering St Malo, you must have a French EHC. If you are travelling onwards, you may need certificates to transit any countries you may travel through as well as the country of final destination.

Your agency or ferry/airline operator may ask you to provide a copy of the export health certificate(s) so that they can forward to Customs before you travel to allow the authorities time to carry out any checks they may wish to carry out. The contact for Condor Ferries freight is: Freight.StMalo@morvanvoyages.com.

We strongly suggest that exporters obtain full details of the importing country's requirements for Customs and from the veterinary authorities in the country concerned, or their representatives in the UK, in advance of travelling.

It is the owners/exporters responsibility to obtain a CITES application form from the department if the rabbits/rodents are specified under the Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES). The EHC will be signed by your Veterinary Surgeon who must be authorised by the department. Please note that any fees charged by your Veterinary Surgeon is a private matter between you and your Vet.

We need at least 10 working days to issue the export health certificate. If we do not hold a certificate, it may take much longer. We aim to send the EHC to your nominated vet at least 1 week before the proposed export date so that your vet can prepare the export health certificate. Your vet may need to see your pet before to carry out any treatment or test required by the EHC.
