A1. The Council, with reference to its Minute No. B2 of 25th September 2020 and with Mr. A. Metcalfe, Head of Strategic Planning and Accountability, Strategic Policy, Planning and Performance and Mr. D. Danino-Forsyth, Director of Communications in attendance, considered a final draft of the Government Plan 2021-24.

The Council was advised that the circulated version was undergoing final checks and proofreading, and that any amendments to the content should be highlighted immediately. A ministerial briefing, explaining the communications strategy ahead of the launch, would be held on 9th October 2020.

The Council approved the final design and content, subject to any final amendments, approval of which was delegated to the Chief Minister and Minister for Treasury and Resources. It was accordingly agreed that the final version of the Government Plan 2021-24 should be lodged '*au Greffe*' on 12th October 2020, for consideration by the States Assembly on 14th December 2020.

The Chief Minister, Senator J.A.N. Le Fondré, expressed thanks on behalf of the entire Council to all colleagues across government for their exceptional efforts throughout the process.
