**EU Legislation (Sanctions – Somalia) (Amendment) (Jersey) Order 2018 R&O.11/2018**

This Order was made by the Minister for External Relations on 2nd February 2018 and came into force on 3rd February 2018. This Order amends the EU Legislation (Sanctions – Somalia) (Jersey) Order 2014 so as to give effect in Jersey to Council Regulation (EU) 2017/2415 of 21 December 2017 (OJ L 343/33, 22.12.2017) amending, as at 23rd December 2017, Regulation (EU) No 356/2010 imposing certain specific restrictive measures directed against certain natural or legal persons, entities or bodies, in view of the situation in Somalia. The effect of the amendment is to permit the making available of funds or economic resources necessary to ensure the timely delivery of urgently needed humanitarian assistance in Somalia by the United Nations, its specialised agencies or programmes.
