Dear States Member,

a petition to have the Samares rehabilitation Ward Last August at Overdale reinstated. This petition quickly surpassed the 1,000 signatures needed for a response from the health minister, but he ignored his responsibilities until the JEP contacted him and asked him why he had not responded 94 days after he should have. I have resisted responding to him, until now

In his response published by the media he says: "Health and Community Services continues to provide a flexible and comprehensive stroke rehabilitation approach - one that is responsive to individual clinical need and good practice guidance. Rehabilitation services have not been reduced but are being delivered in different settings and in a number of different ways in line with National Clinical Guidelines for rehabilitation".

Really? Tell that to the patients that I know you have met personally and who are telling you and your senior officers a quite different story, Deputy Renouf. The people who are stuck at home, many unable to walk at all and who are getting absolutely zero physiotherapy from HCS. The lucky ones are those who have sufficient means to pay for private carers and physiotherapists. Those who cannot are effectively being written off.

He says that there are 14 beds available in Plemont Ward but as of 10th January there are 21 patients in that ward. The toilets and bathrooms are too small and cannot accommodate a hoist. Patients have no privacy or rest and one thing stroke patients in particular need is sufficient rest as part of their recovery. The bays provided are cramped and patients must use a commode by the bed as they cannot access the bathrooms with no hoists. In short, it is a scandal.

The Minister states that "HCS will be commissioning a review from an expert in rehabilitation services to review existing provision and advise upon the future direction and resource requirements of services locally". Why? Are our consultants at Overdale not experts in rehabilitation services? Do we have to waste more money getting a review which will be slanted to say what the minister wants it to say rather than the truth?

The truth is that the clinical lead in the Our Hospital project failed to speak with the Consultants at Overdale and then, when he did so, he apparently told them that if they wanted such a unit they could pay for it themselves

The minister says that "HCS is currently looking to recruit a consultant in stroke medicine and a consultant in frailty which will enhance the rehabilitation provision further." Why? We already have three Consultants at Overdale.

The Deputy states that "In Jersey, the number of persons diagnosed with a stroke is between 100 and 140 people annually." That is about half the UK national average, and I would assert that that figure is entirely fictitious

The minister also fails to recognise that Samares was not just for stroke victims. It was used for treating patients with a host of other medical conditions - all types of head trauma, hip replacement, spinal injury, brain injury, routine orthopaedic surgery's (hips, knees etc.), traumatic orthopaedic injuries (car and b ke crashes, falls, jumpers from building etc.), complex medical conditions including the occasional cardiac patients. Neurological patients such as Guillane Barre were also accepted, Functional Neurological Disorders and some people with long term degenerative diseases such as MS, Parkinson's, and Motor Neurone Disease were given short-term intensive rehabilitation to improve their function and/or to trial new medications or alter current medications.

They would accept spinal cord injury patients once the acute phase or immediate rehabilitation had been completed, usually in the U.K., and the complex discharge planning, including alterations to their homes or new property were ready. They were also able to bring in patients for a two-week assessment to improve their recovery using the on-site Occupational Therapy, Physio, Speech Therapy, Psychology, Optometry, Psychology, Social Work and Medics. It was a very efficient way of developing an effective post rehabilitation support plan. Sadly, this is no longer happening, and communication is practically zero.

Next Tuesday, 18th January, Deputy Steve Pallet is to bring a proposition to the States to reinstate Samares Ward. There is no reason why the ward at Overdale cannot be reopened until such time as planning permission is granted for the hospital build. On no account should the building at Overdale be destroyed when we do not know that the hospital will eventually go there. If planning permission is granted the ward will have to be moved elsewhere until such time as it can be reinstated as a part of the new build. As proposed delivering formal rehabilitation of seriously ill and injured patients in 12 bedrooms scattered among the medical wards of the new hospital, is simply unacceptable - unless you are happy to write off the patients who depend on this previously excellent service?

Our entire health service is in crisis. With an election looming, our politicians need urgently and seriously to look at what is being proposed and developed in their name. Rehabilitation is currently a living scandal and must be changed back to Samares Ward and this replicated in the new hospital campus.
