Worth noting that adverse events are known to be grossly under reported some indicators show that reports could represent 10% of actual adverse events or less. This is owing to the lack of awareness of reporting methods and the reluctance of reporting in the medical sector. I do mention this in the VIBJSY document previously provided.

Dear Tom and Peter

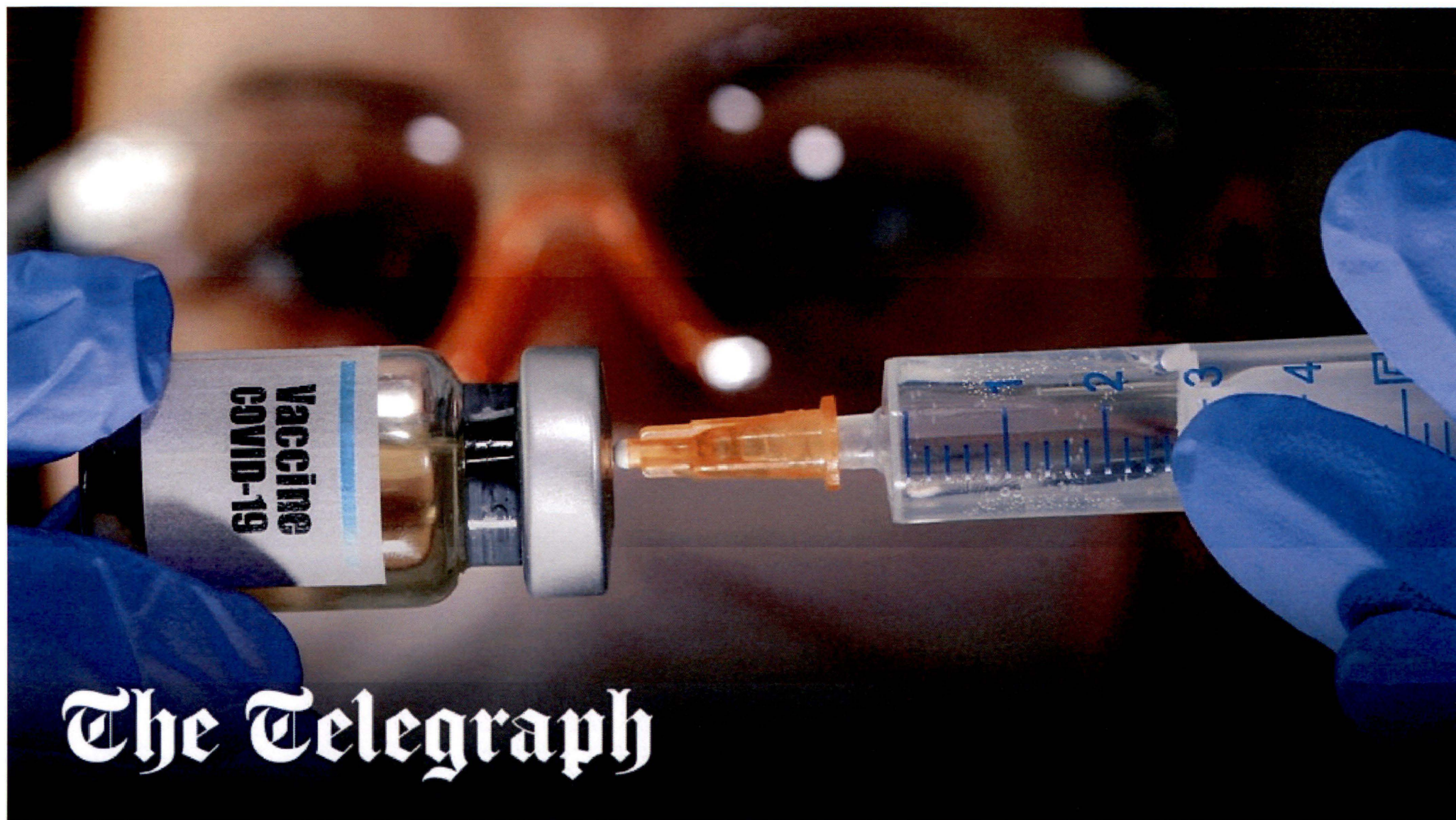
I trust you are both well.
