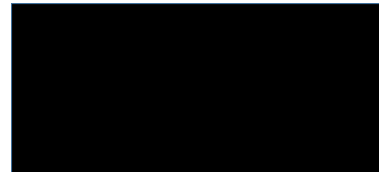

6. The Committee with reference to Act No. 13 of 9th June 1993 of the Committee as previously constituted, received a report from the Assistant Director (Resources) in relation to the negotiations with Thatchers Limited to advance work on the "B" Block building at Highlands.

The Committee noted that the Assistant Director (Resources) had experienced difficulties in establishing a working relationship with the contractor who had not demonstrated "goodwill".

The Committee was disappointed in the attitude of the contractor and decided that it would no longer allow Thatchers Limited to tender for any of its work. A full report would be brought to the Committee on the completion of the project.
