Please note, the 'Other injury or accident' category, is made up largely of earlier incidents from Q4 2020.

Since the new reporting standard, we have added the 'School related injury sustained through sport or play' which now caters for the majority of other incidents.

In addition, 'Related to underlying condition' was also added in the new reporting system. These figures would have previously been recorded as 'other', during Q4 2020.
