## What is the Citizens' Panel and the context of choosing a site for the new hospital - RB

• RB led a discussion with the Citizens' Panel about the context and principles of convening a Citizens' Panel who, would consider and determine the criteria for appraising a long list of sites for a new hospital, with a view to identifying a short list of sites. RB outlined how these questions would be used to develop a 'sequential test' that would be applied by a selection panel to appraise the long list of sites.

## Citizens' Panel Terms of Reference – CW/RB

- CW/RB outlined the draft Terms of Reference for the Citizens' Panel and invited them to discuss.
- CW/RB described the process used to ensure that the Citizens' Panel is representative of the Island i.e. demographics and residency in the Parishes of Jersey.
- CW/RB asked the Citizens' Panel to consider whether a list of all members of the Citizens' Panel should be put on the Government website. Panel members were assured that their identities would not be made public unless they consented to do so.
- Citizens' Panel member voted unanimously that they wish to remain anonymous.

#### **Review of Terms of Reference** – Facilitator

- The Facilitator invited the members of the Citizens' Panel to review the document and share their thoughts.
  - $\circ$  anything that is unclear that they would like explained.
  - o anything they think should be rephrased to be clearer.
  - $\circ$  anything they think should be added or taken out.
  - o anything that they want to learn more about.
  - o anything they need individually or as a group to fulfil their role effectively.
- It was agreed that a revised version of the Terms of Reference would be circulated before next session.
