I wanted to reach out to you to express our sincere apologies for the situation regarding the communication with Lucy Stephenson and the Evening Post. When [REDACTED] was first contacted by Lucy it now appears that clearly she did so under false pretense suggesting that she was seeking to report on the results of the golf outing. Disappointing, but that is the tact that some reporters choose to take.
