Please can you encourage your colleagues to re-consider the current forced closure of gyms on the island?

The established evidence shows that gyms increase immunity and reduce co-morbidities (such as those related to COVID). Closing them will likely make islanders more vulnerable and increase the hospitalisation rate.

There is no evidence that the transmission risk outweighs the above benefits. At the very least, there is scope for personal choice here, informed by medical advice.

Furthermore, gyms will help the increasing rates of mental illness, substance abuse and suicide.

I'm yet to see any data suggesting that gyms have a net negative impact. Closing them will likely do more harm than help.
