Dear Mr Young,

I write to relay my extreme concern on the proposed roll out of 5G, fifth generation telecommunication networks, in Jersey and the support that the States of Jersey and CICRA has provided to telecommunication companies to expedite the deployment of this technology.

There has been no Governmental or CICRA review of the environmental and human health impacts of moving forward with 5G as far as I am aware.

The States of Jersey do not appear to have implemented any specific rules for 5G deployment without first studying the safety of 5G for humans and the environment and this new 5G technology will impact us all in a very serious way. If 5G is built, radiation levels will increase 10- to 100-fold, virtually overnight.

These high frequency wavelengths penetrate only the outer layer of the skin, unlike 2G, 3G and 4G technology which passes through the body. Major health concerns with exposure to 5G are to skin, eye and adverse systemic metabolic signaling through skin sensors, as well as heat effects. There are also significant concerns regarding damage to the environment, with harm to insects and bacteria.

There is consensus within the scientific community that the existing limits for wireless radiation do not protect the population from biological effects.

244 EMF (electromagnetic field) Scientists from 41 nations around the globe are urgently calling upon the United Nations and its sub organisations, the WHO and UNEP and all Member States for greater health protection on EMF Exposure:(https://www.emfscientist.org</hr>



In addition, in April this year the International Society of Doctors for the Environment (ISDE) adopted a declaration calling for a moratorium on the deployment of 5G in the European Union. They state in the declaration that, 'We believe it should be unethical to ignore the available evidence waiting a poss ble "a posteriori" demonstration of health damages in the presence of a present and potentially manageable risk for public health'.

Furthermore scientists and doctors worldwide are calling for a halt to the 5G rollout. Last year over 180 scientists and doctors issued a declaration to officials of the European Commission demanding a moratorium on the increase cell antennas for planned 5G expansion and concerns over health effects from high radiation exposure include potential neurological impacts, infertility and cancer.

Peer reviewed, published science indicates that exposures to wireless radiation can increase cancer risk and alter brain development and damage sperm. Most people are unaware that wireless technology was never tested for long-term safety, that children are more vulnerable and that the accumulated scientific evidence shows harm.

A letter from oncologist Lennart Hardell MD & Colleagues stated that "There is a substantial body of evidence that this technology is harmful to humans and the environment. The 5G millimeter wave is known to heat the eyes, skin and testes... Of particular concern are the most vulnerable among us - the unborn, children, the infirm, the elderly and the disabled. It is also expected that populations of bees and birds will drastically decline."

5G will add in another layer of wireless radiation to our environment. 5G will not only utilize wireless frequencies already in use but also add in higher frequencies - submillimeter and millimeter waves in order to transmit data at superfast speeds.

Communities are being stripped of their right to make decisions about this new technology, we have not been advised when and where, (small cells?), this technology will be deployed. CICRA's press release in the summer on this subject did not mention the concerns and potential health effects of this technology. We are not being provided the relevant balanced information and have no voice in relation to the rollout of 5G which is unacceptable. I have written to CICRA for their comment and requested a moratorium the rollout of 5G until evidence has been provided that it is safe for deployment.

Public notice and public hearings are not even on the agenda yet telecom businesses and CICRA are working full steam ahead to benefit from the opportunities of revenue streams the deployment of this technology will bring to shareholders. Whilst I am not against technology and the improvements and advances it can bring for all of us, it has to be SAFE.

Please immediately halt the rollout of 5G technology in Jersey until a full, independent and thorough public review is undertaken and all the evidence has been researched and considered.

Please advise how you are guaranteeing my safety and the safety of the public and our environment by allowing the 'streamlining' of 5G testing an rollout.	t

I am writing in response to your e-mail to the Minister of Health regarding the proposed roll out of 5G.

I have taken the opportunity to read again the available research and to discuss the subject with our Professional Body, the Chartered Institute of Environmental Health (CIEH). I apologise for the delay this has caused between your e-mail and my response. Mea culpa.

As you are aware the licencing of the mobile Network falls under the remit of the Channel Islands Competition and Regulatory Authorities (CICRA). It is not the Minister of Health who is facilitating 5G testing or rollout. Neither is it within his gift to halt it.

CICRA regularly monitors radio wave emissions from the cellular masts in the Bailiwicks of Guernsey and Jersey to ensure the mobile network operators who operate their services from those masts comply with their license obligations in terms of power levels and that the emissions from the sites comply with internationally recognised standards and guidelines regarding Health & Safety limits for the public. Their reports are all published on the web and can be viewed at https://mastsurveys.cicra.gg/jersey-audit/ .

CICRA commission monitoring against international standards set by the International Commission on Non-Ionizing Radiation Protection (ICNIRP) https://www.icnirp.org/en/about-icnirp/aim-status-history/index.html

The CIEH and ICNIRP are fully appraised of the latest research around poss ble health risks associated with non-ionising radiation and it is to them we would look when we advise on such matters.

Masts require planning permission and the process for such applications is well established. The Minister of Health is a Statutory Consultee in all Planning matters, from the point of view of health. Environmental Health advises the Minister in this respect. Any objection to such masts from, or on behalf of, the Minister for Health must be health related. As with any application for planning permission, applications for 5G are advertised and may be subject to objection from members of the Public

While understanding your concerns, our advice is that there is insufficient evidence to object to the erection of phone masts for 5G on health grounds. We will continue to take account of research and peer-reviewed journals on this subject and advise the Minister accordingly.

Regards

The adoption and roll out of 5G mobile in Jersey is in the early stages. I can assure you that the States of Jersey, regulators and network operators consider matters of public safety extremely seriously and we will ensure that the roll out of 5G is safe and meets recognised international standards. 5G networks in Jersey will be regulated by the Channel Islands Competition & Regulatory Authorities (CICRA), and all mobile masts (current and future) need to adhere to health and safety emission limits prescribed by the International Commission on Non-Ionizing Radiation Protection (ICNIRP). These emission standards are recognised by the World Health Organisation (WHO) and are used within the European Union and other regions.

It may reassure you to know that CICRA already audit Jersey's mobile telecom operators mobile masts and all of these operate within the ICNIRP safe limits. Details of the latest audit can be found here: https://www.cicra.gg/telecoms-masts/

I wonder if you could please answer a very simple question for me?

As I'm sure you're aware the roll-out of 5G will soon begin across the island. As I'm sure you're also aware, 5G is a very different technology to the current 4G network, despite the name suggesting it's a mere advancement of the same.
