AND for the government of Our said Island of Jersey whenever by reason of your absence therefrom or from any other cause whatsoever the duties appertaining to the Office of Lieutenant-Governor and Commander-in-Chief of Our said Island must of necessity be performed by a Deputy We do hereby ordain that Our Bailiff, or, in the event of his inability to act, Our Deputy Bailiff, shall, after taking the usual oath, discharge the duties of the Lieutenant-Governor and Commander-in-Chief until such time as you shall resume the duties, or until We signify Our further pleasure in that behalf.
