- Mental Health Improvement: Both areas have identified deficits with the current provision settings of Mental Health (as well documented). Government Plan initiatives have been shared and there is agreement that some of the key developments requiring investment could be considered as part of a Joint arrangement. This includes;

- The telephone helpline element of the Mental Health Listening Lounge
- The Dementia Strategy
- Suicide Prevention Strategy
- Mental Health Law Application & Review
- CAMHS

Financial Benefits Realisation: HCS have submitted business cases as part of the Government Plan for the required improvement in mental Health services. For Jersey HCS a joint initiative regarding the above key areas of Improvement could result in improved financial efficiency. The costs of the Dementia and Suicide Prevention Strategy alone is estimated at over 1m. Jersey HCS estimates a range of opportunity between XXXX by pursuing joint working in this area.

Mental Health Placements: Both Jurisdictions are reviewing the opportunity to reduce 'off island' placements for Mental Health by providing an 'On Island' service (to be agreed where).

Hi Rob, Julian,


I'm confused how the funding for this training issue has not yet been resolved unless it is a deliberate position which I am not aware of since stepping further back from this work.

I have been raising the issue for the lead and funding of the otherwise successful Connecting With People training for some time. This has been included in requests for priority suicide work to be taken forward as part of the MHIB. The funding for this has been supported from within HCS and the Mental Health Strategy following its original shared pump priming back in 2016. I know Karen has also raised this issue several times but it remains unresolved.

I have expressed frustrations on progressing prevention of suicide priorities for some time, it would appear we are even challenged in continuing our existing commitments. Hopefully, a position or decision on this issue will have surfaced before we meet to discuss a much needed lead for the suicide prevention work in late August.
