6. Of these how many received financial remuneration – and how much?

Of those who have been dismissed only their contractual entitlements were paid. No compensation for loss of office took place as a result of dismissal.

7. How much did it cost the department in terms of salaries paid during suspension?

- No. suspensions = 17 at a total of £76,604 or £4506 average per suspension
- No. suspensions = 17 at a total cost of £110,798 or £6517 average per suspension
- 2014 No. suspensions = 19 at a total cost of £141,416 or £7443 average per suspension
- 7.1 Cost by department has not been provided due to the potential for employee salaries' to be identifiable.
- 7.2 The cost is calculated using employee basic pay only (it does not include employer's pension and Social Security contributions).
