- · The number of rapes reported to the States of Jersey police in 2012, 2013 & 2014
- The number of sexual assaults reported to the States of Jersey Police in 2012/2013/2014
- The status of these reports (being investigated, charged, conviction, withdrawn, dropped for lack of evidence)
- · If the report resulted in a conviction, what sentence was passed down by the court.
- · How many of those convicted of rape and sexual assault, have previous convictions and what were they for.

Response

The below tables follow on from each other. The first depicts the Rape and Indecent assault stats for 2012 to 2014. We have split them to show how many happened in the year of recording and those that were being reported as Historic, (Over a year old, but in most cases, from many years ago) This is to show what is happening now instead of showing figures distorted by historical reports.

The second table splits the Undetected crimes into, Ongoing, Completed and Discontinued crimes.

The third table splits the discontinued crimes into the reasons, Insufficient evidence and Complaint withdrawn.

We are unable to provide details of individual case results or previous conviction data as I believe this would be in breach of the Data Protection Law. Even by providing anonymised information, for such high profile cases, it could lead to the identification of individuals and as such is covered by the Fol Law exemption in Art 25, Personal information.

It is my decision that the Public Interest test on releasing such Third Party sensitive personal information is not passed. The harm it may cause to the individual far outweighs any public interest or right to know such information in this case.
