

Comments

Minister proposes P.130, as amended. He may wish to do so as amended by paragraph 1 of the 4th Amendment and paragraph 1 of the 2nd Amendment

If so, paragraph 1 of the 4th Amendment and paragraph 1 of the 2nd Amendment are adopted

Alternatively, after P.130, as amended, is seconded, the Minister will be invited to propose paragraph 1 of the 4th Amendment which is debated and voted on in the normal way, followed by paragraph 1 of the 2nd Amendment, which is dealt with similarly.

Deputy Le Fondré is invited to propose paragraph 1 of the 3rd Amendment on behalf of the Corporate Services Scrutiny Panel. This amendment is debated and voted on in the normal way.

Deputy Le Fondré is invited to propose paragraphs 2, 3, 4 and 5 of the 3rd Amendment on behalf of the panel. These must be taken together as they are inter-linked. The paragraphs are treated as one amendment, debated and voted on in the normal way. If these paragraphs are adopted, paragraphs 2, 3, 5, 6 and 8 of the 2nd Amendment and paragraph 2 of the 4th Amendment fall away.

IF paragraphs 2 to 5 of the 3rd Amendment are adopted, the Minister will be invited to propose paragraph 4 of the 2nd Amendment, which will be debated and voted on in the normal way. Similarly, the Minister will next be invited to propose paragraph 7 of the 2nd Amendment which will be dealt with in the normal way.

IF paragraphs 2 to 5 of the 3rd Amendment are rejected, the Minister will be invited to propose paragraph 2 of the 4th Amendment

The Minister could seek to take paragraphs 4 and 7 together, although members may request separate votes on the paragraphs.

IF paragraphs 2 to 5 of the 3rd Amendment are rejected, the Minister will be invited to propose paragraphs 2, 3 (as amended - subject to the agreement of the Assembly), 5, 6 and 8 of the 2nd Amendment, which must be taken together as they are inter-linked. The paragraphs are treated as one amendment, debated and voted on in the normal way. The Minister will next be invited to propose paragraph 4 of the 2nd Amendment and then paragraph 7 of the 2nd Amendment, both of which are debated and voted on separately in the normal way.

The Minister could seek to take all the remaining paragraphs of the 2nd Amendment together, although members may request separate votes.

Once the amendments are dealt with, debate on the proposition, as amended, resumes. Once concluded, it is voted on in the normal way.
