Dear all,

I would like to invite you to join us on Monday 21 January to participate in a workshop to scope the model and requirements for the first 'Jersey Children's Day' in 2019. The key output from the workshop will be a commissioning brief for the co-ordination and delivery of the Day. We are delighted that the Minister for Children and Housing, Senator Sam Mézec has agreed to open this workshop. A further stage in the planning process will involve engagement with local children and young people via the School Council Network.

The creation of Jersey Children's Day is one of the four elements of the legacy recommended by the Jersey Citizen's Panel in response to the Care Inquiry. An overview of the process which was followed and the recommendations and criteria proposed by the Citizens Panel is available here: <https://www.gov.je/government/departments/homeaffairs/respondingtoindependentjerseycareinquiry/pages/carememorial.aspx>

The creation of a Citizens Panel, comprising survivors and members of the wider public, was suggested by Ministers in their response to the recommendations made by the Care Inquiry. The Citizens Panel was recruited in spring 2018 and met for five days to consider how Jersey should remember those who had been harmed by the failings of the care system. The Panel has now been reconvened to enable them to shape and inform the implementation of the legacy; representatives from the Citizens Panel will be participating in this workshop which will be facilitated by Peter Bryant and Claire Mason from Contact Consulting.

Due to a period of construction work at Jersey Museum, please can we ask you to meet in the lobby area just ahead of 11:00am as our route to the room may be affected by the works. Lunch and refreshments will be provided; please let me know if you have any dietary requirements. If you are unable to join us on the day, please can we ask you to nominate a colleague to represent you.

I hope to have the pleasure of welcoming you to this important event on 21 January.
