The campaign has made a good start, with a high level of interest from the public. Out of over 70 initial enquiries to date, 12 potential carers are actively engaged in a process of familiarisation with the role leading to formal assessment and training. (National experience in foster care recruitment shows that 8-10% of initial enquiries go on to be approved as viable carers, so the figures above reflect a very positive start).
