Declaration:

I am making this application as the registered owner of an XL Bully type dog.

1. I understand the requirements listed under *the “Dogs Law (Jersey) Amendment Regulations 2025”*
2. Conditions on the registration document must be complied with throughout the lifetime of the dog, or by the date specified in the conditions, for the dog to remain in compliance with the legislation.
3. I understand that failure to comply with any of the requirements referred to in 1 above may result in the seizure of the dog by a Police Officer and maybe destroyed following a court order.
4. I understand that it is a criminal offence to keep a dog of this type after 31st December 2025, without being registered with the Animal Health and Welfare Team. Non-compliance with the mandatory registration may result in the seizure of the dog by a Police Officer and maybe destroyed following a court order.
5. I undertake I must ensure the dog is accommodated in premises that are secure, appropriate to its welfare and in such a manner as to prevent the dog's escape.
6. I understand that it is my responsibility as the dog owner to ensure that I am compliant with all other relevant legislation relating to the ownership of the dog.
7. I understand that it is illegal to do any of the following in relation to the dog:
 - I. Abandon, give away, sell or otherwise transfer ownership.
 - II. Allow the dog to stray.
 - III. Fail to keep the dog muzzled, with a muzzle suitable for the dog when in a public place.
 - IV. Fail to keep the dog under the control of a person over 18 years old when in a public place.
 - V. Fail to keep the dog on a lead that adequately controls the dog when in a public place.
 - VI. Fail to keep the dog in secure conditions that prevent it from escaping.
 - VII. Fail to keep the dog at the registered address for more than 30 days per year without prior approval from the Animal Health and Welfare Team.
 - VIII. Fail to notify the Animal Health and Welfare Team in advance of temporary change of address.
 - IX. Leave the dog unsupervised with anyone less than 18 years old.
 - X. Fail to have valid third-party public liability insurance in respect of the dog.
 - XI. Fail to surgically neuter the dog before it reaches 18 months old.
