## Water Resources (Jersey) Law 2007

### Application form to register a water abstraction

Please complete this form to register a water abstraction (i.e. from a borehole, well, etc). This includes if you abstract water from a borehole or well solely for the domestic purposes of a household (regardless of how much water you take) OR if you abstract from a water source for non-domestic use (such as a business) if the quantity does not exceed 15 cubic metres (3300 gallons) in any 24 hour period.

#### How much water is 15 m<sup>3</sup>?

1. 15 m<sup>3</sup> (or 3300 gallons) is far more water than a household can normally use in one day
2. 15 m<sup>3</sup> = 75 full baths or 75 large drums (44 gallon)

There is no charge for registering or using a registered borehole or well.

This form should not be used if a water source is already registered. Please download the amendment/transfer form and contact Environmental Protection for your registration number.
