DECLARATION OF SPECIAL MEASURES: FOOT AND MOUTH DISEASE IMPORTATION OF SUSCEPTIBLE ANIMALS AND ANIMAL PRODUCTS FROM RESTRICTED ZONE IN GERMANY, WHOLE OF AUSTRIA, HUNGARY and SLOVAKIA

Animal Health (Jersey) Law 2016

Animal Health (Importation of Miscellaneous Goods and Animals) (Jersey) Order 2017

EU Legislation (Veterinary and Zootechnical Checks – Trade with Member States) (Jersey) Regulations 2016

The Minister for the Environment

- a. Has reasonable grounds for suspecting the existence of Foot and Mouth disease in certain third countries and territories, such that certain animals and animal products originating from territories subject to special transitional import arrangements are liable to pose a risk to animal health.
- b. In exercise of the powers conferred under Regulation 15 of the EU Legislation (Veterinary and Zootechnical Checks – Trade with Member States) (Jersey) Regulations 2016 the Minister for the Environment declares the following special measures to be necessary in Jersey to contain the risk to animal health:
 - 1. Suspension of entry into Jersey of the following animal products from susceptible animals originating from the restricted zone in Germany, whole of Austria, Hungary and Slovakia:
 - 1.1 fresh meat from ungulates
 - 1.2 meat products from ungulates that have not been subject to specific treatment D1 or higher (including wild game)

- 1.3 milk, colostrum and their products, unless subjected to treatment as defined in Article 4 of Regulation 2010/605
- 1.4 animal by-products, unless treated to effectively mitigate the risk of FMD

2 Interpretation

In this Declaration:

- a) "susceptible animals" means a cow, bull, sheep, goat, porcine, deer, camel, llama, alpaca, guanaco, vicuna, any other ruminant, elephant
- b) "the restricted zone in Germany" means the area listed in Annex II to Commission Implementing Decision (EU) 2025/323 of 11 February 2025 concerning certain emergency measures relating to foot and mouth disease in Germany and repealing Implementing Decision (EU) 2025/186(2), as it has effect in EU law on the date this Declaration is made

This declaration supersedes the declaration issued on 07/03/2025 with title - DECLARATION OF SPECIAL MEASURES: FOOT AND MOUTH DISEASE IMPORTATION OF SUSCEPTIBLE ANIMALS AND ANIMAL PRODUCTS FROM GERMANY, HUNGARY and SLOVAKIA
