Discussed fuel duty increase and clarified that it will be the increase above RPI that will go into the fund. Noted that it covered petrol and diesel and not other fuels

Noted that the Government Plan debate is on 26th November and that nothing is agreed until then LM noted the British Irish Council meeting and the high level political discussion on the climate emergency that senior States Members were involved in LM noted that the bid for funds for 2019 was approved and that this money is being used on commissioning policy analysis work. 	 Members noted the Ministerial sign off of their amended Terms of Reference Discussion ensued regarding the draft Press Release on the new TOR The Forum agreed that the release should 'Welcome the establishment of the Fund that will build over the course of time to provide funds to address the Climate Emergency' It was agreed that within the notes for the Editor the release should provide a link to the interim report on gov.je and provide information on who / what the Energy Forum is and links to the appropriate page on gov.je 	JeH to amend and finalise release and circulate to press

	LM gave a presentation on the definition of

- included within the Carbon Neutral Strategy
- Members agreed that the Carbon Neutral Strategy would aim for net-zero emissions by 2030 rather than zero emissions
- Members agreed that Scope 1 and Scope 2 should be included within the Carbon Neutral Strategy
- LM clarified that the current Energy Plan and our international reporting obligations only cover Scope 1 emissions
- Members agreed that although consideration of Scope 3 emissions was very important it was not going to be possible to measure and account for these within the Carbon Neutral Strategy
- Members agreed that an education programme was crucial to the Carbon Neutral Strategy and that highlighting the carbon footprint of all aspects of our every day lives and supporting people to make changes was important
- It was also agreed that a 'just transition' needed to play a key role in the strategy

6. Presentation followed by group discussion on Carbon Offsetting

- LJ gave a presentation on carbon offsetting
- The Members agreed that the policing of carbon offset projects was very important
- The Members agreed that all offsets purchased for the Carbon Neutral Strategy should be verified and adhere to the highest standard (such as the Gold Standard or equivalent)

7. AOB

- Membership the Forum noted that three members had not attended meetings for a year.
- Additional meetings it was agreed that the next few months will be critical in the development of the Carbon Neutral Strategy and that it was necessary for the Forum to meet on a monthly basis and to circulate information electronically between meetings.
