# Veterinary confirmation of neutering

Confirm an XL Bully type dog has been neutered.

---

## When to use this form

Owners of XL Bully type dogs who want to keep their dog must provide evidence of neutering to the Chief Veterinary Officer, Animal Health and Welfare Team.

The Animal Health and Welfare Team will use the form as evidence that the owner has met the neutering requirement for the dog to be registered under the **“Dogs Law (Jersey) Amendment Regulations 2025”**

Male dogs must be neutered through castration, and female dogs must be spayed. The procedure must be carried out by an RCVS-registered veterinary surgeon, or they must confirm that the dog has been previously neutered. If the dog was:

- 18 months or older on 2 December 2025, you must provide the Animal Health and Welfare Team with proof of neutering by 31 December 2025
- younger than 18 months on 2 December 2025, you must provide the Animal Health and Welfare Team with proof of neutering by 31 March 2026 or within one month of the dog reaching the age of 18 months, whichever is later

The Animal Health and Welfare Team will contact the dog owner if there are any issues verifying the information on this form.
