Appendix to the supplementary guidance on domestic abuse Examples of domestic abuse offences

 Example of behaviour: Neglecting, abandoning or ill-treating a child Possible offence: Child cruelty Charge/Legislation: Article 35 of the Children (Jersey) Law 2002

2) Example of behaviour: Forcing entry into a house

Possible offence: Using violence to secure entry **Charge/Legislation:** Customary law offence: breaking and entering and committing an offence (assault/larceny/malicious damage), breaking and entering with intent to commit a crime (assault/malicious damage), malicious damage

3) Example of behaviour: Pressuring a victim/witness to "drop the case" or not to give evidence

Possible offence: Perverting the course of justice **Charge/Legislation:** Customary law offence: perverting or attempting to pervert the course of justice

4) Example of behaviour: Physical violence, with or without weapons (eg: punching, slapping, pushing, kicking, headbutting, and hair pulling)

- a) Possible offence: Common assault Charge/Legislation: Customary law offence: common assault

5) Example of behaviour: Neglecting, abusing or ill-treating an individual whereupon the act has caused serious physical harm or death

- a) **Possible offence:** Grave and criminal assault

- b) Possible offence: Murder, attempted murder or manslaughter

- 6) Example of behaviour: Violence resulting in death

- 7) Example of behaviour: Offensive/obscene/menacing telephone calls, text messages, letters, emails, social media/online messages, verbal communication

- 8) Example of behaviour: Posting of intimate images, messages, or defamatory/insulting material

- 9) Example of behaviour: Excessive contact (eg: numerous phone calls to check someone's whereabouts, leaving unexpected/unwanted gifts, defamation of character to friends/family's employers etc)

10) Example of behaviour: Following an individual physically

Possible offence: Harassment

- 11) Example of behaviour: Constantly visiting an individual (or their friends'/family's) home, workplace or regularly known location Possible offence: Harassment

- 12) Example of behaviour: Threatening with an article used as a weapon (eg: a knife, tool, telephone, chair)

 - c) Possible offence: Breach of the peace Charge/Legislation: Customary law offence: breach of the peace

- 13) Example of behaviour: Throwing articles (eg: crockery, even if they miss their target)

17) Example of behaviour: Threats seriously to damage or undermine social status a) Possible offence: Blackmail

- **b) Possible offence:** Posting or causing to be posted any mail for transmission by a postal operator if the mail is, or contains, anything indecent, obscene or grossly offensive

18) Example of behaviour: Damaging or destroying property or threatening to damage or destroy property

19) Example of behaviour: Harming or threatening to harm a pet

- c) Possible offence: Cruelty to animals

- 20) Example of behaviour: Locking someone in a room or house or preventing him or her from leaving

Possible offence: False imprisonment

26) Example of behaviour: "Outing" (eg: sexual orientation or HIV status)

- 27) Example of behaviour: Enforced financial dependence or unreasonably depriving someone of money

28) Example of behaviour: Enforced sexual activity

- a) Possible offence: Rape Charge/Legislation: Article 5 Sexual Offences (Jersey) Law 2018
- b) Possible offence: Sexual penetration without consent Charge/legislation: Article 6 Sexual Offences (Jersey) Law 2018
- c) **Possible offence:** Sexual touching without consent Charge/legislation: Article 7 Sexual Offences (Jersey) Law 2018
- d) Possible offence: Causing a sexual act without consent
 Charge/legislation: Article 8 Sexual Offences (Jersey) Law 2018
- e) Possible offence: Causing, inciting or controlling prostitution for gain
 Charge/legislation: Article 25 Sexual Offences (Jersey) Law 2018
- f) Possible offence: Indecent assault
 Charge/Legislation: Customary law offence: indecent assault.

For offences committed prior to **23 November 2018**, the following Customary law offences may be charged:

- b) Possible offence: Procuring an act of gross indecency

- 29) Example of behaviour: Removal or mutilation of whole or any part of a girl's external genitalia for non-medical reasons

- 30) Example of behaviour: Persistent verbal abuse (eg: constant unreasonable criticism)

32) Example of behaviour: Secret or enforced administration of drugs

- a) Possible offence: Administering a substance to stupefy or overpower a person for sexual purposes
