REVIEW OF THE ISLAND PLAN TO REZONE LAND FOR LIFE-LONG DWELLINGS FOR THE OVER 55s' AND FIRST TIME BUYER HOMES

November 2007

The Minister and Assistant Minister for Planning and Environment are carrying out a review of the Island Plan with a view to rezoning land for Category A housing which will provide for lifelong dwellings for the over 55s' and first time buyers homes

The consultation paper seeks to provide Category A homes on 12 sites across the Island, yielding approximately 450 homes in total, which if approved by the States, will provide approximately 345 retirement dwellings and 105 first-time buyer homes.

The proposals are set out in the attached report entitled 'Review of the Island Plan to Rezone Land for Life-Long Dwellings for the Over 55s' and First Time Buyer Homes'. In addition to providing for social rented retirement dwellings and first time buyer homes, the report introduces the concept of 'downsizing' which would enable existing home owners to downsize from existing family homes and acquire purpose built-life long homes. Selling their existing home will release equity to assist retirement and also put family homes back into the market place.

The proposed sites have initially been identified in consultation with the relevant Parish Connetable and the Minister, having been satisfied of the housing need, has reviewed the sites and agreed to put them forward in the consultation document for public comment.

In accordance with Article 3 of the Planning and Building (Jersey) Law 2002, an 8 week public consultation period will now begin. The consultation will be led by the Assistant Minister for Planning and Environment, Deputy Anne Pryke, who has responsibility for all social housing matters within the Department.

During the consultation period, public and focus group meetings will be held and details will be published in the gazette section of the Jersey Evening Post.
