Declarations of interest.

Minutes.

A2 The Minutes of the meeting of 17th June 2025 (Part B only), having previously been circulated, were taken as read and were confirmed.

Forthcoming business.

A3. The Council discussed the following items of public business, which were scheduled to be considered at the meeting of the States Assembly on 8th July 2025

Draft Residential Tenancy (Jersey) Amendment Law 202- (P.24/2025)

It was noted that the Environment, Housing and Infrastructure Scrutiny Panel had intimated that they would 'call in' the draft Law for review. As a consequence, only the principles would be debated on 8th July 2025. The Scrutiny Panel had launched a review of P.24/2025 but had not yet produced its findings and it was envisaged that these could include some minor proposed amendments. A much more substantive amendment was noted to have been lodged by Deputy Sir P.M. Bailhache of St. Clement;

<u>Draft Children and Young People (Place of Police Detention) (Jersey) Amendment</u> <u>Law 202- (P.40/2025)</u>

The Council was informed that, at present, when a child or young person was charged with a criminal offence and denied bail, Centeniers could only remand them to be held in secure accommodation or at Police Headquarters if the former was not possible. The draft law introduced the option of transferring individuals to suitable accommodation provided by the Minister for Children and Families, thereby enhancing compliance with the United Nations Convention on the Rights of a Child and aligning with the provisions in other jurisdictions including England, Wales and Guernsey;

Draft Financial Services (Jersey) Amendment Law 202- (P.41/2025)

It was noted that the draft law would introduce a 2-tier regulatory framework for consumer credit businesses and that these activities would be overseen by the Jersey Financial Services Commission (JFSC) and Trading Standards. The Council was informed that Trading Standards was already involved in the supervision of the voluntary code of practice for consumer lending but that the Department might require additional resources and support to implement the new regulations that provided basic consumer protection;

Draft Bank (Recovery and Resolution) (Jersey) Amendment Law 202- (P.42/2025) The Council was informed that this proposition was predominantly administrative in nature and would transfer the functions of the Jersey Bank Depositor Compensation Board to the Jersey Resolution Authority, thereby creating a single decision-making body;

<u>Draft Criminal Justice (Young Offenders) (Jersey) Amendment Law 202-</u> (P.43/2025)

The Council noted that members of the Youth Court were currently required to retire at the age of 60 years and that the draft law had the effect of increasing the retirement age to 70 years;

Draft Civil Status (Abolition of Legitimacy etc) (Jersey) Law 202- (P.44/2025)

It was noted that the draft law would abolish the status of legitimacy, except in a small number of circumstances. Only children born to married parents in a mixed-sex relationship were currently afforded the status 'legitimate' and this was an outdated and discriminatory concept. The draft law enhanced rights and had been modelled on legislation already in force in Scotland.
