Declarations of interest.

A1. No declarations of interest were received from Ministers in connexion with any of the items discussed at the current meeting.

Forthcoming business.

A2. The Council discussed the following items of public business, which were scheduled to be debated by the States Assembly at the meetings on 16th July and 10th September 2024-

# Fully funding education or training for all 16-18 year olds (P.38/2024)

It was recalled that comments, rejecting the proposition of Deputy I. Gardiner of St. Helier North, had been prepared but had not yet been presented, in anticipation that the proposer might either amend or withdraw P.38/2024;

## New Healthcare Facilities Programme (P.43/2024)

Deputy T.J.A. Binet of St. Saviour, Minister for Health and Social Services, informed the Council that this proposition of the Hospital Review Panel had the potential to delay the New Healthcare Facilities programme and, as such, should be rejected. It was agreed that comments to this effect would be prepared; and

# Minimum Wage: increase to match the living wage (P.19/2024)

The Council was reminded that Caritas, which assessed the living wage, had requested Deputy M.B. Andrews of St. Helier North, who had lodged the proposition, not to include its calculations therein. The Council was minded to reject the proposition, as it was contrary to the policy contained within the Common Strategic Policy and noted that comments to this effect would be prepared in due course.

Quorum.

A3. The Council, with reference to Minute No. A2 of the meeting of 20th June 2018 of the Council, as previously constituted, recalled that, when the Council had comprised 11 and subsequently 12 members, the quorum had been determined to be 6. However, as there were now 13 Ministers, it was proposed that the quorum should formally be confirmed as 7 and this was agreed.

On a related note, the Council was reminded that only the votes of Ministers were counted when reaching a decision, unless an Assistant Minister was attending all or part of a meeting in the absence of the Minister. In such instances, the Assistant Minister would, for the purposes of determining the quorum, be afforded full voting rights in lieu of the Minister concerned. It was agreed that it would be confirmed at the start of a meeting of the Council if any Assistant Minister would be acting on behalf of a Minister.
