Statutory Guidance: Consultation

Introduction to guidance on the Children and Young People (Jersey) Law 2022

- The Law was enacted to strengthen strategic planning for children and young people and introduces specific measures to promote the wellbeing of and safeguard children and young people, particularly the most vulnerable. This Law is part of a commitment to update Jersey's legislative framework in response to the 2017 Independent Jersey Care Inquiry Report.
- 2. This guidance has been written to support practitioners and partners working with and for children to understand their roles and responsibilities under the Children and Young People (Jersey) Law 2022.
- 3. All practitioners and partners must play their part in promoting the wellbeing and safeguarding the welfare of children and young people. This is the overriding objective of the Law.
- 4. This guidance also outlines the arrangements that support practitioners and partners to identify and respond to different presentations of need at any point in a child's life:
 - Wellbeing need
 - Health and development need
 - Safeguarding need
- 5. Underpinning that response to need is sharing the right information with the right people at the right time. The guidance will support practitioners and partners to be confident in their decision to share or not to share information.
- 6. This guidance also supports the range of measures designed to improve the outcomes of looked after children and care leavers. It outlines the responsibilities of corporate parents, social workers, personal advisors, Independent Reviewing Officers and the Virtual School Head.
- 7. Finally, this guidance outlines the process around reviewing child deaths.
- 8. At the heart of it, this guidance is about the relationship of practitioners and partners with children and young people, and their families, and the role of practitioners and partners in supporting them on both an individual and collective basis. The needs of children must guide professional judgement, and practitioners and partners must commit to playing their part in the network of support across Jersey.
