The Parish of St Saviour and Government of Jersey (GoJ) are working together on Safer Routes to Schools as part of the St Saviour Schools Action Plan.

After consultation in October 2018 the feedback from the public was in support of the Wellington Road zebra crossing scheme which is due to be constructed in summer 2019.

The next route to be improved for safer walking is Bagatelle Lane and its links to Schools.

Please take time to look at the information on the panels for Bagatelle Lane, what public needs and concerns were raised at the previous consultation and what the proposed improvements are help address these concerns.



The initial consultation on 25th October gave the following results:





There is a issue with road safety that needs to be addressed Most people walk or drive through the area




Too many cars and pedestrians sharing limited space

INTRODUCTION



Key Features

Kerb build-outs at junctions to help pedestrians cross and improve visibility for road users
One-way in northbound direction
Virtual footway along one side
Bollard protection for pedestrians, spaced to maintain access to properties

On-street parking removed from Bagatelle Lane Possible traffic calming in the form of chicanes or raised tables

Impact on Les Varines

In the AM peak 50 cars might redirect towards the Les Varines junction Marginal impact on the junction overall delay

Example of planters for

traffic calming

Drivers using the route to cut through will re-route

Why was this option chosen?

One-way northbound - provides better visibility Currently there is a higher percentage of traffic traveling in a northbound direction

The visibility at Bagatelle Road junction is poor and difficult to improve

No space for two-way traffic and footway No space for on-street parking and footway Virtual footway allows for turning movements into premises



Traffic calming included in the scheme:







:Potential additional traffic calming:

Planters





- ✓ Targets a specific part of the road
- ✓ Emergency vehicles may be able to travel faster around a chicane compared to vertical treatments
- ✓ Can prevent vehicle parking
- ✓ More attractive

Negatives

- Not as effective as vertical treatments
- Managing water drainage could be complex and costly
- Cyclists may feel intimidated by some vehicle drivers' behaviour at road narrowing
- Can resemble a sheltered parking bay and encourage parking each side which can mask pedestrians.

Raised Tables



Postives

- Most effective traffic calming treatment
- Can be used as part of an informal crossing for pedestrians
- ✓ The size of the speed table is flexible to fit an area with a safety concern.

Negatives

- Noise and vibrations can be unpopular with neighbouring householders
- Cyclists and emergency vehicles may need to slow down
- Signs are required to warn drivers of speed humps, and these contribute to sign clutter
- Additional cost may be required to resurface sections of the road.
