Island Plan interim review (1) MN. (3): La Preference, St Martin

Heritage status

During discussion at the Examination in Public at the session for the site of La Preference Cottage, St. Martin (MN.(3): 10.20-10.40 am, 21 January 2014) a query was raised in relation to the heritage status of the adjacent La Preference Children's Home, which is owned by the States of Jersey and administered by Jersey Property Holdings. This could not be answered at the session.

The purpose of this brief note is to clarify the factual position with regard to the heritage status of the site.

The building is Listed because of its architectural and historical interest: it has been assigned a non-statutory Grade 4.

It is considered to be a good example of rural detached mid C19 Gothic villa, retaining some external features.

iv)	Description	Detached, 2 storey with attic, 3 bay with central tower. Pitched slate roof with large gable to west bay and smaller gable to east bay, elaborate iron crosses set on cruciform plinths at end of each gable above rendered coping, remains of decorative cresting, small lancet windows in gables with hood mouldings. Front (south) elevation: render in ashlar effect, raised quoins; central octagonal 3 storey entrance tower, replacement door, moulded string courses, cusped lancet window to 1st floor, hood moulding, blind moulded quatrefoil to 2nd

floor, crenellated parapet. Ground floor: to west canted bay window, replacement; position of east window obscured by modern single storey extension. 1st floor: replacement windows, hood mouldings. Modern extensions to west, east and north. Set behind large lawn above the junction to south, large rendered gate piers; coursed granite rubble wall to road (La Route de St Martin), rendered arched pedestrian doorway, blocked; curving drive around lawn to tower. The interior of the property is not of interest. Double fronted, central hallway and staircase, west side double pile, east side single pile. Outer hall, deep skirting, Gothic-headed niche with moulded timber frame in east wall, replacement timber double door with overlight to inner hall. Staircase with moulded strings, elegant mahogany handrail and slender turned balusters (newel gone); painted timber panelling and 4 panelled door (replacement) to cupboard below. 2 round-headed classical niches in walls flanking half landing, moulded surrounds, round-headed arch to west side leading to attic stairs. Hallway with deep skirting, ceiling rose in acanthus leaf relief pattern, 2 four panelled timber doors to west ground floor rooms. No other original features internally as much alteration and subdivision for use as childrens' home.


