SPIRITS

of all kinds (including liqueurs, essences, etc. and beverages based on spirits) of a strength exceeding 1.2% abv

WINES AND MADE WINES

(including fortified wines and beverages based on wines and/or made wines)

exceeding 1.2% abv but not exceeding 5.5% abv	£72.51 per hectolitre
exceeding 5.5% abv but not exceeding 15.0% abv	£190.29 per hectolitre
exceeding 15.0% abv but not exceeding 22.0% abv	£233.19 per hectolitre

Produced by a small independent maker of cider
