
## Average Turnaround Times of Applications in Q1 2019




#### **Registered Permissions Granted and Removed**

The below line-graph shows:


- the total number of permanent and seasonal registered permissions that have been granted per quarter since the 1st January 2016

### Total Registered permissions held per sector as of 31st March 2019




### **Registration Cards issued in Q1 2019**

## Summary of employment status:

Employment Status	Definition	Employment
Entitled	Someone who has lived in Jersey for 10 years or who is grant- ed this status on hardship or on social or economic grounds	Someone who can work anywhere
Entitled for work only	Someone who has lived in Jersey continuously for the last 5 years, or is the spouse or civil partner of someone who is Enti- tled, Licensed, or Entitled for Work Only	Someone who can work anywhere
Licensed	Someone who is an 'Essential Employee' engaged by a specific business with permission to engage such a person	Employer needs permission to employ a 'licensed' person
Registered	Someone who does not qualify under the above categories	Employer needs permissions to employ a 'registered' person
