HSSD Clinical Directors meet every other week with the Jersey General Hospital Medical Director, Managing Director and Operations Director. Through 2014 and 2015 Clinical Directors have received briefings on the progress of the Future Hospital Project each month. This comprehensive clinical engagement has been invaluable in providing advice and guidance on the developing Acute Service Strategy and, in particular, the New Clinical Model described by the Strategy.

As the Site Options Appraisal Project has progressed Clinical Directors were, therefore, in a strong and informed position to advise on how clinical adjacencies and patient flows within the respective Site Options might be improved to best support the safety, sustainability and affordability of services that would be provided on each site. They had a clear appreciation of how each might best work for the benefit of patients, staff and the Island's health and social care more generally.

The participation of the General Hospital Operations Director, Medical Director and Deputy Operations Director on the Site Options Risk and Benefits Workshops led by Gleeds Management Services (on 26 March and 22 September 2015) also provided an important means of assuring Clinical Directors that their views with respect to the risks and benefits associated with each site were given due consideration in the formal appraisal process.

The site plans and 'stacking diagrams' have been shared with Clinical Directors and they have been able to observe how their feedback has been incorporated into the evolving design of each of the Options.

An important conclusion of the Clinical Directors is the necessity to implement as much of the New Clinical Model before the opening of the new building. This work would need to be progressed irrespective of the development of a new hospital if the health challenges on the Island are to be met.
