  - b) Drawings /Photos of the structures to be used including dimensions and any surface materials and buoyage.
    - c) Schematic of the layout of the farm.
- 3. If there is insufficient space on the application form use additional pages.
- 4. Applicants may be asked to supply further evidence and references to support application

### Additional Information for Applications by a Company

- 1. If an application is made in the name of a corporate body, all directors must sign the application form
- 2. In the case of an application by a corporate body registered under the Loi (1861) sur les Sociétés à Responsibilité Limitée, a copy of the Memorandum and Articles of Association and any special resolution of the Company, relating to its objects must be submitted.
- 3. In the case of an application of corporate body incorporated in any other manner, a copy of every instrument of incorporation relating to the corporate body must be submitted.
- 4. If application is made in the name of a corporate body, experience and qualifications of directors or senior technical staff should be supplied.

Pursuant to Article 23 of the Sea Fisheries (Jersey) Law 1994 it is an offence to knowingly or recklessly make any statement or provide any information that is false or misleading in a material way particularly in or in connection with any application, or in providing any information under the Sea Fisheries (Fisheries)(Jersey) Regulations 2010. A person found guilty of this offence is liable to imprisonment for a term not exceeding 12 months or to a fine not exceeding level 4 on the standard scale
