IMPORTATION OF CERTAIN PRODUCTS OF SUSCEPTIBLE ANIMALS FROM
GERMANY

The Minister for the Environment

- a. Has reasonable grounds for suspecting the existence of Foot and Mouth disease in Germany, such that certain products originating from the restricted area in Germany are liable to pose a risk to animal health.
- b. In exercise of the powers conferred under Regulation 15 of the EU Legislation (Veterinary and Zootechnical Checks – Trade with Member States) (Jersey) Regulations 2016 the Minister for the Environment declares the following special measures to be necessary in Jersey to contain the risk to animal health:

- 1. Suspension of entry into Jersey of the** following products not intended for human consumption originated from the restricted area in Germany and obtained from a susceptible animal, unless they are an intermediate product, research and diagnostic samples or trade samples
 - 1.1 hay and straw
 - 1.2 the following products not intended for human consumption obtained from a susceptible animal:

- 1.2.1 rendered fats, except rendered fats not for uses in the feed chain for farmed animals, for petfood or for feed to fur animals, and which have been subjected to any of the processing methods 1 to 5 as referred to in Chapter 3 of Annex 4 to Commission Regulation (EU) No 142/2011,
- 1.2.2 fat derivatives, unless subjected to one of the following processes –
 - 1.2.2.1 any of the processing methods 1 to 5 as referred to in Chapter 3 of Annex 4 to Commission Regulation (EU) No 142/2011,
 - 1.2.2.2 transesterification or hydrolysis at a temperature of at least 200°C, under corresponding appropriate pressure, for at least 20 minutes (glycerol, fatty acids and esters)
 - 1.2.2.3 saponification with NaOH 12M (glycerol and soap) in a batch process at 95°C for three hours or in a continuous process at 140°C 2 bars (2000 hPa) for eight minutes, or
 - 1.2.2.4 hydrogenation at 160 °C at 12 bars (12000 hPa) for 20 minutes,
- 1.2.3 milk, milk-based products, milk-derived products, colostrum and colostrum products,
- 1.2.4 manure
- 1.2.5 hides and skins, except:
 - 1.2.5.1 hides and skins having undergone the complete process of tanning,
 - 1.2.5.2 'wet blue',
 - 1.2.5.3 'pickled pelts', and
 - 1.2.5.4 limed hides (treated with lime and in brine at a pH of 12 to 13 for at least eight hours)
- 1.2.6 game trophies or other preparations consisting of entire anatomical parts, not having been treated in any way,
- 1.2.7 treated game trophies or other preparations, being solely comprised of bones, horns, hooves, claws, antlers or teeth, except those referred to in paragraph 1 of Section 5 of Chapter 2 of Annex 14 to Commission Regulation (EU) No 142/2011, unless they have:

- 1.2.7.1 been immersed in boiling water for an appropriate time so as to ensure that any matter other than bone, horns, hooves, claws, antlers or teeth is removed, and
- 1.2.7.2 been disinfected with hydrogen peroxide where parts consisting of bone are concerned,
- 1.2.8 treated game trophies or other preparations comprised of hides and skins, except those referred to in paragraph 1 of Section 5 of Chapter 2 of Annex 14 to Commission Regulation (EU) No 142/2011,
- 1.2.9 pig bristles, unless they have been boiled for a minimum of one hour,
- 1.2.10 wool or hair, unless it complies with sub-paragraph (c) or (d) of Article 25(2) of Commission Regulation (EU) No 142/2011
- 1.2.11 bones and bone products, horns and horn products and hooves and hoof products intended for use other than as feed material, organic fertilisers or soil improvers, unless subjected to one of the treatments referred to in points (iii), (iv) and (v) of paragraph 2(d) in Section 7 of Chapter 2 of Annex 14 to Commission Regulation (EU) No 142/2011, confirmed in the commercial document accompanying the consignment by the competent authority supervising the establishment of origin,
- 1.2.12 pet food, including dogchews, except :
 - 1.2.12.1 canned petfood,
 - 1.2.12.2 processed petfood, where the processed petfood has been subjected to one of the treatments referred to in points (i), (ii), (iii) or (v) of paragraph 3(b) of Chapter 2 of Annex 13 to Commission Regulation (EU) No 142/2011, and
 - 1.2.12.3 dogchews produced from material of animal origin other than untanned hides and skins.

2. Interpretation – in this declaration


- 2.1 the restricted zone in Germany” means the area listed in Annex II to Commission Implementing Decision (EU) 2025/323 of 11 February 2025 concerning certain emergency measures relating to foot and mouth disease in Germany and repealing Implementing Decision (EU)

2025/186(2), as it has effect in EU law on the date this Declaration is made,

2.2 “susceptible animal” means cattle, a sheep, goat, deer, camel, llama, alpaca, guanaco, vicuna, any other ruminant, any swine (that is, a member of the suborder Suina of the order Artiodactyla), an elephant

2.3 “Commission Regulation (EU) No. 142/2011” means Commission Regulation (EU) No 142/2011 of 25 February 2011 implementing Regulation (EC) No 1069/2009 of the European Parliament and of the Council laying down health rules as regards animal by-products and derived products not intended for human consumption and implementing Council Directive 97/78/EC as regards certain samples and items exempt from veterinary checks at the border under that Directive.

- 3 Expressions used in this Declaration that are also used in Commission Regulation (EU) No. 142/2011, or Regulation (EC) No 1069/2009 of the European Parliament and of the Council of 21 October 2009 laying down health rules as regards animal by-products and derived products not intended for human consumption and repealing Regulation (EC) No 1774/2002(3), have the same meaning in this Declaration as they have in those instruments, as the context may require.
- 4 This declaration revokes “DECLARATION OF SPECIAL MEASURES: FOOT AND MOUTH DISEASE IMPORTATION OF CERTAIN PRODUCTS OF SUSCEPTIBLE ANIMALS FROM GERMANY, HUNGARY AND SLOVAKIA issued on the by the Environment Minister on the 7th March 2025.
