## Declaration notes

I understand:

That if I want to fish for lobsters, crawfish or crabs without being subject to catch restrictions I must ensure that my parent UK licence is endorsed to permit unrestricted shell fishing (shellfish entitlement). (NB. All Crab and Lobster Pots must be fitted with a valid pot tag. Pot tag application forms are available from the department upon request).

That licence holders for vessels under 10 metres are required to submit quarterly catch returns using the official paper or online logbook published by the department. Please note the paper logbooks are due to be phased out, therefore, where possible, catch returns should be completed and submitted online.

That the issue of a commercial fishing licence does not override my responsibility to obtain the necessary permissions, licences or authorisations which may be required under any other relevant legislation.

That PO's are officially recognised bodies set up by fishery or aquaculture producers and they play a role in managing quotas and marketing the fisheries products of their members.

That the licence fee is £112 and all cheques should be made payable to the 'Treasurer of the States'.

That all logbook returns will be treated with the strictest confidence and no individual return or part of return will be published without my authority. However, the department may use grouped figures to publish statistics for the fishing industry as a whole.

That I will comply with the conditions attached to the licence and any future conditions made by the Minister.

That the information supplied in this form, together with any other accompanying information, is to be used for the processing of my application for a commercial fishing licence in accordance with the Sea Fisheries (Jersey) Law 1994 and Sea Fisheries (Licensing of Fishing Boats)(Jersey) Regulations 2003.
