Diseases of Animals (Pigs, Goats and Sheep Registration, Identification and Movement) (Jersey) Order 2007 (“The Order”)

Application to Register as a Pig, Sheep and Goat Keeper

The Order is made under the Animal Health (Jersey) Law 2016. Articles 2 and 3 of the Order require a keeper of pigs, sheep and goats to register and keep certain records.

A keeper of pigs, sheep and goats must record births, deaths and movements on and off the holding by completing a farm register. The farm register should be completed at the time of each notifiable event by the keeper or person responsible for the animals at the premises where they are kept. A sample farm register is available for use from the department or you can download one from our government website at www.gov.je.

If you keep pigs, goats and sheep at more than one premises then you must enter all addresses on the application form and advise which species are kept at each holding. Your registers must be kept for inspection for 6 years. Please contact the department to de-register when you no longer wish to keep animals.

Failure to observe the measures required under the Order is an offence under Article 29 of the Animal Health (Jersey) Law 2016. A person guilty of an offence under this Article is liable to imprisonment for a term of 2 years and to a fine.
