# The European Communities Legislation (Implementation) (Cattle Identification) (Jersey) Regulations 2002 ("The regulations")

Application to register as a keeper of cattle.

The regulations require keepers of cattle to register and to keep certain records.

A keeper of cattle must record births, deaths and movements on and off the holding by completing a farm register. The farm register should be completed at the time of each notifiable event by the keeper or person responsible for the animals at the premises where they are kept. A sample farm register is available for use from the department or you can download one from our government website at <u>www.gov.je</u>

Farm registers must be kept for inspection for 10 years from the end of the year in which the last entry was recorded. Please contact the department to de-register when you no longer wish to keep animals.
