## **SCHEDULE 2**

### Licence Conditions Applicable To '10 metre and Under' Jersey Fishing Boat Licence

# **AUTHORITY**

Subject to the conditions set out below, and to any prohibition on fishing imposed by Regulation or Order under the Sea Fisheries (Jersey) Law, 1994, the vessel to which this licence is issued is authorised to fish in the territorial sea of Jersey.

#### **VALIDITY OF LICENCE**

This licence is valid from 0001 hours on the issue date specified on the licence and expires at 2359 hours on the expiry date specified on the licence, subject to any revocation, suspension or variation.

This licence may be revoked, suspended, or varied at any time by a notice communicated in accordance with the Sea Fisheries (Licensing of Fishing Boats) (Jersey) Regulations 2003.

In accordance with regulation 10(3) of the Sea Fisheries (Licensing of Fishing Boats) (Jersey) Regulations 2003, notices may be published on the www.gov.je website.

This licence is invalid if the Marine Management Organisation (MMO) licence held by this vessel is transferred or becomes an entitlement.

The licence may also cease to have effect if by virtue of an Order of the Court the licensee has been disqualified from holding a licence in respect of the vessel.

This licence is invalid if any of the details on pages 1 and 2 of the licence change.

This licence does not authorise non-Jersey registered fishing vessels to fish within the Jersey three mile limit.

For the purposes of this licence the Jersey three mile limit means the area of sea within the area of three nautical miles measured from low tide elevations of the Island of Jersey and the offshore islands and reefs, as shown in Chart A in part III of the annex.

#### **CONDITIONS**

### 1.0 General Conditions

1.1 This licence must be carried on board the boat to which it relates at all times and be produced on demand to any Jersey Sea Fishery Officer.

# 1.2 Change of Details

Any unauthorised change of the vessel or ownership details recorded on this licence will immediately make this licence invalid. These details must match those on vessels Certificate of Registry and Marine Management Organisation (MMO) licence. Any difference will invalidate this licence.

### 1.3 Species for which you may not fish

This licence does not authorise the vessel to which this licence relates to fish for or land sea fish of the description set out in Part I of the Annex to this Schedule. Any such sea fish so caught must be returned to the sea immediately, unless authorised as a permitted bycatch.

## **Permitted By-catches**

- 1.3.a This licence does not authorise fishing for sword fish. An incidental by-catch of two fish of this species will however be allowed to be retained on board during any fishing trip.
- 1.3.b This licence does not authorise fishing for albacore tuna. However, a fishing vessel may retain onboard any albacore tuna caught as a permitted by-catch when fishing for other species.
- 1.3.c This licence does not authorise fishing for crawfish during the period 1<sup>st</sup> January to 31<sup>st</sup> May (inclusive). However, a fishing vessel may retain on board one crawfish caught as a permitted by-catch when fishing for other species during this period.

#### 1.4 Economic Link

- 1.4.a The owner of a vessel registered in Jersey, must maintain an economic link between the vessel to which this licence is applied and the Bailiwick of Jersey.
- 1.4.b A Jersey registered vessel must be permanently based in and operating from the Island of Jersey.
- 1.4.c The owner (or in the case of a vessel registered to a limited liability company, the beneficial owner) of a Jersey registered vessel must be principally resident in Jersey. Such an owner shall be treated as being principally resident in Jersey in any calendar year if in that year they spend 182 days or more in Jersey.

# 1.5 **Logbooks**

Licence holders are required to provide statistical information with regard to their fishing effort and catches by completing and submitting quarterly logbook returns, from the official paper or online under 10m logbook published by the Department of the Environment, in accordance with the instructions as appended at Schedule 3 of this licence.

# 1.6 Landing catch direct to France

- 1.6.a Where a Jersey vessel lands its catch directly into France, all necessary EU IUU (Illegal, Unreported and Unregulated fishing) documentation, including a Catch Certificate, Prior Notification of Landing and Pre Landing Declaration forms must be completed and submitted within the required time frames to the Centre National de Surveillance des Pêche at <a href="mailto:cnsp-france@developpement-durable.gouv.fr">cnsp-france@developpement-durable.gouv.fr</a> and copied to Marine Resources at fisheries@gov.je
- 1.6.b The licence holder(s) must ensure that the relevant electronic Port State Control (PSC) form under the North East Atlantic Fisheries Commission (NEAFC) Port State Control System is completed and submitted within the required time frame in advance of landing. A PDF copy of the fully completed PSC form authorising landing must be copied to Marine Resources at fisheries@gov.je
- 1.6.c In addition, an up to date logbook must be completed for the vessel and submitted to the Jersey Marine Resources Office within 24 hours of completion of the landing.

#### 2.0 Conditions relating to the use of Fishing Gear

## 2.1 Mobile Fishing Gear

- 2.1.a This licence does not authorise fishing with mobile fishing gear, which includes all types of dredges or trawls.
- 2.1.b The vessel to which this licence relates may only fish using mobile fishing gear (which includes all types of dredges and trawls), if the holder of this licence is in possession of a written "Mobile Gear Authorisation" issued by the Minister.

### 2.2 Beam Trawling Restriction

No person shall, from the fishing vessel for which this licence relates use more than one beam trawl.

### 2.3 Restriction on the number of scallop dredges that can be towed on each side of a vessel

- 2.3.a The vessel to which this licence relates shall not tow or use more than one beam (to which scallop dredges are attached) from either side of the vessel or any beam to which more than six scallop dredges are attached.
- 2.3.b It is prohibited to carry onboard more than two beams to which scallop dredges are attached and to carry onboard any beam to which more than six scallop dredges are attached, unless the beams and

dredges that would cause these limitations to be exceeded are stowed in a way in which they may not readily be used.

- 2.3.c The vessel to which this licence relates shall not tow or use a number of scallop dredges at any one time with aggregate mouth sizes that exceed 9.6 metres.
- 2.3.d It is prohibited to carry onboard a number of scallop dredges with aggregate mouth sizes that exceed 9.6 metres unless the dredges that would cause that size to be exceeded are stowed in a way in which they may not readily be used.

## 2.4 Restriction on the use of mobile gear in inshore areas

The vessel to which this licence relates shall not tow or use any mobile gear (which includes all dredges and trawls) within a restricted zone.

It is prohibited to carry onboard in a restricted zone, any mobile gear unless it is stowed in a way in which it may not readily be used.

## 2.5 Sea Bream nesting - mobile gear restricted zones

The vessel to which this licence relates shall not tow or use any mobile gear (which includes all dredges and trawls) within a restricted zone for the period 00:00 hours on 1st April to 23:59 hours on 31st July each calendar year. The following restricted zones are shown in chart B in part III of the Annex.

### 3.0 Conditions relating to Minimum Size of Fish

#### 3.1 Minimum Landing Size for Skate & Ray

No person shall land in Jersey from the fishing vessel that this licence relates, Skate or Ray being smaller than 40cm measured from wing tip to wing tip.

### 3.2 Minimum Landing Size for Sole

No person shall land in Jersey from the fishing vessel to which this licence relates, sole (*Solea vulgaris*) being smaller than 26cm measured from the tip of the snout to the extreme end of the tail fin.

### 3.3 Minimum Landing Size for Whelks

No person shall land in Jersey from the fishing vessel to which this licence relates, Whelk (*Buccinum undatum*) having a length of less than 50 millimetres.

### 4.0 Conditions relating to Catch Restrictions

Any fishing boat which holds a 10 metre and under Jersey licence shall abide by the UK quota restrictions for TAC species ICES area VIIE specified in the current annex to the vessel's MMO licence and any additional catch restrictions specified in this schedule.

4.1 The authority of this licence is subject to the Non Sector – 10 metre and under catch limits applicable for ICES sea area VIIE as specified in the MMO licence annex. These catch limits are published on the website specified in the annex to this schedule and can change on a regular basis. It is the responsibility of owners and masters to ensure that the licensed vessel is fishing within the current catch limits.

The quota limitations shall apply concurrently with, and not in addition to, any other quota limitations for the time being in force which have been imposed by any other licence issued by any other authority, wherever established.

All quantitative limitations are in live weight, and relate to the maximum amount that may be caught and retained on board, landed or transhipped per calendar month unless otherwise stated. Live weight can be calculated by multiplying landed weight by the conversion factors set out in the table published on the Website specified in the annex to this schedule.

- 4.1.a Subject to paragraph 4.1.b below, any fish which are subject to quota which are retained on board and not returned to the sea immediately in accordance with Article 6 (paragraph 5) of the Sea Fisheries (Jersey Law) 1994, shall be landed and counted against quota.
- 4.1.b The provision in paragraph 4.1.a above shall not apply in respect of fish which:

are undersized, or

the vessel is not authorised to land by virtue of any limitations contained in the schedule to this licence, and which are caught in waters where the discarding of certain species is prohibited. All such fish shall be discarded immediately on return to Jersey Waters.

#### 4.1.c Processing of Fish

All species of Skate and Ray must be landed whole. Skinning and the removal of wings and other parts of all species of Skate and Ray may not take place onboard.

### 4.2 Shellfish Catch and Storage Restrictions

Only a vessel whose licence is endorsed to allow unrestricted fishing for shellfish, may fish for shellfish using pots or fixed nets, without being subject to catch and storage restrictions. Vessels whose licence is not endorsed are subject to the limitations set out below. All quantitative limitations are in actual numbers of shellfish. For the purpose of Conditions 4.2 to 4.5, 'shellfish' means lobsters (*Homarus gammarus*), crawfish (*Palinurus spp.*), edible crabs (*Cancer pagurus*), velvet crabs (*Liocarcinus puber*), spider crabs (*Maia squinado / Maia brachydactyla*) and green crabs (*Carcinus maenas*), and 'crabs' means the four species of crabs so specified.

### 4.3 Lobsters or Crawfish from pots or fixed nets:

- 4.3.a The maximum number of lobsters that may be caught and retained in any day (day being from 0001 hours until 2359 hours) is 15.
- 4.3.b The maximum number of crawfish that may be caught and retained in any day (day being from 0001 hours until 2359 hours) is 15 except during the period 1<sup>st</sup> January to 31<sup>st</sup> May (inclusive) when fishing for crawfish is prohibited. However an incidental by-catch of one crawfish per day is permitted during this period. (see condition 1.3c)
- 4.3.c It is prohibited to retain on board or land berried female crawfish at any time.
- 4.3.d Lobsters or Crawfish may not be transhipped.
- 4.3.e The maximum number of Lobsters or Crawfish that may be landed in any day is 15 except that this number may be increased to 30 during the period 0001 hours until 1700 hours each Monday. Except during the period 1st January to 31st May when the landing is restricted to one crawfish caught as bycatch per day.
- 4.3.f The maximum number of Lobsters or Crawfish that may be possessed in any day (either onboard the licensed vessel and/or in a storepot/storebox) is 15 except that this number may be increased to 30 during the period 0001 hours each Sunday until 1700 hours on the following Monday. Except during the period 1st January to 31st May when the landing is restricted to one crawfish caught as by-catch per day.
- 4.3.g The maximum number of Lobsters or Crawfish that may be carried onboard the licensed vessel at any one time is 15 (except that up to 30 may be carried during the period 0001 hours until 1700 hours each Monday for the purpose of landing). Except during the period 1st January to 31st May when the landing is restricted to one crawfish caught as by-catch per day.

### 4.4 Crabs from pots or fixed nets:

- 4.4.a Subject to the specific exceptions in the following parts of this Condition, the maximum number of Crabs that may be caught and retained in any day (day being from 0001 hours until 2359 hours) is 25.
- 4.4.b Crabs may not be transhipped.
- 4.4.c The maximum number of Crabs that may be landed in any day is 25 except that this number may be increased to 50 during the period 0001 hours until 1700 hours each Monday.
- 4.4.d The maximum number of Crabs that may be possessed in any day (either onboard the licensed vessel and/or in a storepot/storebox) is 25 except that this number may be increased to 50 during the period 0001 hours each Sunday until 1700 hours on the following Monday.
- 4.4.e The maximum number of Crabs that may be carried onboard the licensed vessel at any one time is 25 (except that up to 50 may be carried during the period 0001 hours until 1700 hours each Monday for the purpose of landing).

#### 4.5 Shellfish from towed gear:

Where shellfish (other than green crabs) are caught in trawls it is prohibited to land or tranship shellfish in excess of 5% by weight of the total quantity of fish landed using that method of fishing.

### 4.6 Whelks

- 4.6.a This licence does not authorise fishing for whelks.
- 4.6.b The vessel to which this licence relates may only fish for whelks, using whelk pots (a whelk pot being a pot specifically designed for catching whelks), if the holder of this licence is in possession of a written "Whelk Authorisation" issued by the Minister.
- 4.6.c The holder(s) of a Whelk Authorisation, shall be restricted to a set number of whelk pots not exceeding 900 whelk pots within the Jersey Territorial Sea, as specified in their Whelk Authorisation.

All whelk pots set by license holders with a Whelk Authorisation must be tagged with a valid whelk pot tag issued to that vessel by the Department. Licence holders with a Whelk Authorisation must not use any whelk pots without a valid tag within the Jersey Territorial Sea.

- 4.6.d Where whelks are caught as by-catch using any type of fishing gear other than whelk pots, the maximum live weight of whelks that may be landed in any day (a day being from 0001 hours until 2359 hours) shall be 5kg. In such cases a Whelk Authorisation is not required.
- 4.6.e Licence holders with a Whelk Authorisation, may only set whelk pots to fish for whelks in the area of Jersey's East coast between 002° 02.00' W and 49° 12.00' N shown in Chart C in part III of the Annex between 1st November and 28th February each year. Whelk pots must not be left within this zone outside this period.
- 4.6.f Where grading of whelks for size is conducted using a drum or table type grader, then the spacing between the bars of that grader must be equal to or greater than 22 millimetres.

#### 4.7 FISHING RESTRICTIONS FOR BASS

- 4.7.a This licence authorises fishing for and retaining two bass (*Dicentrarchus labrax*), per person per day, up to a maximum of 10 bass, where there are 5 or more fishers onboard. These limits apply between the hours of 00:00 on 1<sup>st</sup> January and 23:59 on 31<sup>st</sup> January and between the hours of 00:00 on 1<sup>st</sup> April to 23:59 on 31<sup>st</sup> December.
- 4.7.b A vessel to which this licence has been issued may only fish for bass in excess of the limits stated in 4.7.a, using fixed gillnets<sup>2</sup>, hooks and lines<sup>3</sup>, or rod and line<sup>4</sup>, as appropriate, if the holder of this licence is in possession of a written "Bass Authorisation" issued by the Minister in respect of the licensed vessel.
  - All vessels issued with a Bass Authorisation cannot fish for, retain on board, relocate, tranship or land bass during the period 1st February to 31st March.
- 4.7.c Catches of bass by Authorised vessels in accordance with subparagraph 4.7.b shall be subject to a maximum annual limit specified in the Bass Authorisation.
- 4.7.d Vessels authorised in accordance with 4.7.b above shall not carry on board during the same voyage both fixed gillnets and hook and line fishing equipment.
- 4.7.e The minimum mesh size of any fixed gillnets set by a licensed vessel holding a Bass Authorisation, is 100mm. The maximum length of nets to be set by an authorised vessel when targeting bass at any one time is not to exceed 600 metres total length for a single handed boat or 1,200 metres for a boat with two or more crew.
- 4.7.f Fixed gillnets fishing under the netting authorisation must not be set within 200 meters of a pier, sea wall or other harbour structure.
- 4.7.g By way of derogation from 4.7.a it shall be permitted for a vessel deploying:
- (a) demersal trawls or seines<sup>1</sup> to only retain on board unavoidable by-catches of bass that do not exceed 1% of the weight of the total catches of marine organisms on board in any single day and no more than 400 kilogrammes of bass in any two month period.
- (b) fixed gillnets<sup>2</sup> (without an authorisation) to only retain on board unavoidable by-catches of bass that do not exceed 3% of the weight of the total catches of marine organisms caught using fixed nets in any single day.

Such vessels are not authorised to fish for, retain on board, relocate, tranship or land bass during the period 1st February to 31st March.

#### 4.8 FISHING RESTRICTIONS FOR TOPE

No person shall from the fishing vessel for which this licence relates fish for or land tope shark (*Galeorhinus galeus*) when taken with longlines or by rod & line. When accidently caught on longlines or rod and line, tope shark shall not be harmed and be promptly released.

#### 4.9 FISHING RESTRICTIONS FOR EDIBLE CRABS

#### 4.9.a Newly moulted Edible Crabs

No person shall from the fishing vessel for which this licence relates, land or use as bait newly moulted or 'soft shelled' edible crab (*Cancer pagurus*) or parts thereof. Any such crabs taken on board must be returned to the sea forthwith.

Newly moulted edible crabs are defined as crabs whose top shell edge has not yet reached a uniform dark brown and shows pale indentations along the side edges and the claws have a sharp claw tip and / or a mottled light brown colouration on the upper side.

#### 4.9.b **Detached Claws**

When edible crabs are caught using static nets or mobile fishing gear, a maximum of 1% by weight of the total catch of edible crabs or parts of edible crabs retained on board at any one time during a fishing voyage or landed at the end of a fishing voyage may consist of detached claws.

#### 4.10 FISHING RESTRICTIONS FOR UNDULATE RAY

Undulate ray (Raja undulata) may be caught between the hours of 00:01 on 1st January and 23:59 on 30th April; and 00:01 on 1st September and 23:59 of 31st December. The vessel to which this licence relates may retain on board and land undulate ray provided that the quota limits in the licence annex and the following conditions are adhered to:

- (i) No undulate ray which measures less than 78 centimetres when measured from the tip of the snout to the tip of the tail shall be retained on board or landed,
- (ii) No undulate ray which measures more than 97 centimetres when measured from the tip of the snout to the tip of the tail shall be retained on board or landed,
- (iii) No undulate ray may be transhipped,
- (iv) Undulate ray may only be retained on board or landed whole or gutted.

#### 5.0 ADDITIONAL CONDITIONS FOR NEW ENTRANT LICENCES

Holders of a Jersey Fishing Boat Licence granted under the New Entrant Scheme are also subject to the following additional conditions:

- 5.1 Contrary to Part b of the Authority Section of this Schedule New Entrant Licence holders are not authorised to fish within the part of the Granville Bay Area which falls inside the territorial sea of France. New Entrant Licence holders are only authorised to fish within the Jersey Territorial Sea.
- 5.2 New Entrant Licence holders must provide catch data described in condition 1.5 however this data can only be submitted through the Marine Resources' online logbook.
- 5.3 New Entrant Licence holders shall abide by the UK Non Sector 10 metre and under catch limits for TAC species in ICES area VIIE and any additional catch restrictions specified in this schedule. These catch limits are published on the website specified in the annex to this schedule and can change on a regular basis. It is the responsibility of owners and masters to ensure that the licensed vessel is fishing within the current catch limits.
- 5.4 A New Entrant Licence holder must be the Master of their licensed vessel and the vessel cannot be chartered or leased.
- 5.5 A New Entrant Licence holder shall not, from the fishing vessel for which their New Entrant licence has been issued, be permitted to tow or use for the purposes of fishing any mobile gear. This includes use of all types of trawls and dredges.

Any such fish so caught must be returned to the sea immediately unless authorised as a permitted bycatch in the 10m and Under Licence Schedule 2.

# **Part II: Quota Limitations**

The TAC quota species listed in the table below are subject to the ICES sea area VIIE catch limits for Non Sector - 10m and under vessels as quoted in the current annexe to UK 10m and under uncapped licence - Type 9199 which are published on the <a href="https://www.gov.uk">www.gov.uk</a> website.


