(a) L.P.G. storage tanks where the work is to be undertaken by a GAS SAFE registered technician, or where the work involves L.P.G. storage tanks which have a storage capacity of 150 litres (water equivalent) or less.
(b) Oil storage tanks where the work is to be undertaken by an OFTEC registered technician, or where works involve fuel oil storage tanks which have a storage capacity of 90 litres or less.
However, a certificate of completion must be submitted to the department within 30 days of completion of the work by the technician's registration body.

GUIDANCE NOTES

- (a) This form is only to be used for the purpose of obtaining building bye-law permission for work involving the provision of a L.P.G. or fuel oil storage tank, or the provision of cylinder storage facilities for L.P.G. where the installation is intended to serve an appliance in a dwelling.
- (b) Guidance on meeting the building bye-law requirements can be found in the supporting technical guidance documents which can be downloaded from the States of Jersey website, www.gov.je, or purchased from the department.
- (c) Oil storage tanks located within a building are required to be within a 30 minute fire resisting enclosure and vented to external air.
For externally sited tanks refer to the technical guidance information published in support of the bye-law requirements.
- (d) Distances which satisfy the requirements of the bye-laws are stated in the technical guidance information.
- (e) The work detailed on this form may be commenced as soon as the application has been accepted by the department; however the department must be notified not more than 48 hours after completion of the work.
- (f) Every application must include one copy of a location map, which is an authorised direct copy of the current 1:2500 scale map of the Island and the appropriate fee for the works. The fees payable for applications are set out in the department's fee schedule which can be downloaded from the States of Jersey website, www.gov.je, or collected from the department. Cheques should be made payable to the 'Treasurer of the States'.
