CONDITIONS & DECLARATIONS

Conditions

Permits are issued under the following conditions:

1. That the vehicle is not used for any habitable purposes whilst in the Island or, in the case of a motor caravan, that the vehicle is not used for any habitable purposes whilst in the Island and displays Jersey registration plates.
2. That trailer caravans are to be kept out of public sight within a building, whilst in the Island.
3. That the vehicle is not sold or disposed of in any way within the Island without reference to the Environment Department.
4. That the permit holder is a permanent resident of the Island or taking up permanent residence or employment.

Failure to comply with the above conditions will render the owner of the vehicle liable to the penalties under Article 99 of the Planning and Building (Jersey) Law 2002.
