

- 2. When writing the address of the premises, include the post code and building number where applicable. For example: 'The Petrol Station', 15 St Saviour's Road JE2 7BS, and not just 'The Petrol Station' St. Saviour's Road.
- 3. The **Owner** is the person or persons to whom the premises belong. In the case of premises with more than one owner, the names and addresses of all owners should be given.
- 4. Please indicate at Item 4 above the amount of dispensers you have relating to both Petrol and Diesel, these are identified as the dispensing nozzles on the pumping units.
