## NOTES TO ASSIST YOU IN COMPLETING THE APPLICATION FORM OVERLEAF

(4) Your Jersey driving licence number can be found at number 5 on the front of your credit card style driving licence. **Note:** if you have moved to Jersey and are now a permanent resident you MUST obtain a Jersey driving licence immediately from your local parish hall. Information can be found at [www.parish.gov.je](http://www.parish.gov.je). If you do not hold a Jersey driving licence you will need to provide other acceptable proof of identity such as your passport.

(6) If you are resident in Jersey, give the address at which you live. If you are not permanently resident in Jersey give a Jersey address at which you can be contacted. For a company owner give the address of the company's principal place of business in Jersey or it's registered office in Jersey.

**Note:** The Inspector has discretion to refuse registration if the owner is not permanently resident.

(14) Gross Vehicle Weight is the maximum operating weight/mass of a vehicle as specified by the manufacturer.

(15) Unladen weight is the weight/mass of the trailer excluding any load.

### **DO I NEED TO REGISTER MY TRAILER?**

It is a requirement to register your trailer if travelling internationally and it falls within the below 2 categories.

1) A trailer used to carry goods in the course of a business and it has a permissible Gross Vehicle Weight in excess of 750kgs.

2) Other trailers with a permissible Gross Vehicle Weight in excess of 3500kgs.

### **CAN I VOLUNTARILY REGISTER MY TRAILER IF IT DOESN'T FALL INTO THE ABOVE CATEGORIES?**

Yes, it is also possible to register trailers with a permissible Gross Vehicle Weight in excess of 750kgs and below 3500kgs if travelling internationally.

INTERNATIONALLY WITH IT.**
