## CUSTOMS GUIDANCE ON THE EXPORTATION OF HOUSEHOLD EFFECTS

### **Declaring goods on export to Customs**

On export household effects require a written inventory for Customs purposes as certain items are prohibited or restricted or subject to licensing restrictions. In particular goods that have a cultural or artistic value to Jersey including:

- Anything of archaeological interest found within or relating to the Channel Islands
- A photographic image from the Channel Islands more than 50 years old and exceeding a value of £500
- A painting/sculpture or any other items manufactured in the Channel Islands more than 50 years old and exceeding a value of £6000
- A print or any other item of silver more than 50 years old not exceeding a value of £1000
- Any furniture /clock manufactured in the Channel Islands more than
  50 years old and exceeding a value of £3000
- Any book manufactured in the Channel Islands more than 50 years old and exceeding a value of £1000
- Any manuscript, map, architectural, scientific, engineering drawings manufactured/produced in the Channel Islands and more than 50 years old

### Other goods

**Firearms** if exported outside the British Islands.

Any **Animal/plant**, whether dead or alive, or derivatives thereof, of a species listed in Appendices 1-3 of the Endangered Species (Jersey) Law 2012.

### Other goods
