<u>Welcome & Introductions</u>
<p>[redacted] introduced the second meeting to discuss the consensus statement cannabis based products for medicinal use, asked of any conflicts of interest, all confirmed none.</p> <p><u>Update progress since last meeting –</u> [redacted]</p> <ul style="list-style-type: none"> • Took the substance use strategy to the council of ministers, this was generally supported by the ministers • Two key areas to reconsider, 1: [redacted] 2: alcohol policy • [redacted] – on secondment from UK civil service, has been tasked to map out what the position is in Jersey. In terms of regulation information required, how many people are being prescribed medicinal cannabis, how much are they being prescribed/from where. Prescriptions sent to the chief pharmacist need to be audited so data can be collected/analysed for evidence to support a regulatory system. From this meeting today would like opinion how we can put the regulation in place. <p>Group discussion</p> <ul style="list-style-type: none"> • [redacted] – two options for regulating the service, 1: regulating specific cannabis prescribing outside GP services/Hospital 2: independent clinics • [redacted] – care quality commission in UK has a regulatory process in place for clinics, conducting inspections, producing reports. This is something to follow that works.
