COMMUNITY PROVISIONS (RESTRICTIVE MEASURES – CÔTE D’IVOIRE) (AMENDMENT) (JERSEY) ORDER 2011

Made

Coming into force

THE CHIEF MINISTER, in pursuance of Article 2 of the European Communities Legislation (Implementation) (Jersey) Law 1996, orders as follows –

1 Interpretation

In this Order “principal Order” means the Community Provisions (Restrictive Measures – Côte d’Ivoire) (Jersey) Order 2011.

2 Article 1 amended

In Article 1 of the principal Order, in paragraph (a) of the definition “Council Regulation No. 560/2005”, for the words “as amended up to 15th January 2011” there are substituted the words “as amended up to 7th April 2011”.

3 Article 3 amended

In Article 3(4) of the principal Order –

- (a) for sub-paragraph (a) there are substituted the following sub-paragraphs –
- “(a) in Article 3(3) the words ‘, provided that the Member State has notified the grounds on which it considers that a specific authorisation should be granted to all other Member States and to the Commission at least two weeks prior to authorisation’ shall be omitted;
 - (aa) in Article 3a the words ‘, after notification in advance to the other Member States and to the Commission’ shall be omitted;
 - (ab) in Article 3b the proviso ‘The Member State concerned shall, at least two weeks prior to the grant of the

- authorisation, notify the other Member States and the Commission of that determination and its intention to grant an authorisation.’ shall be omitted;
- (ac) Article 5 shall be omitted;”;
- (b) for sub-paragraph (c) there are substituted the following sub-paragraphs –
- “ (c) for Article 10 there shall be substituted the following Article –
- ‘Article 10*
- The Minister may inform a Member State or the Commission of the measures he or she proposes to take, or has taken, under this Regulation and may supply to a Member State or the Commission any other relevant information at his or her disposal in connection with this Regulation.’;
- (ca) Articles 11, 11a, 12 and 12a shall be omitted;”.

4 Article 5 amended

In Article 5(1)(a), for the words “Article 2 or 8 of Council Regulation No. 560/2005” there are substituted the words “Article 2, 8 or 9a of Council Regulation No. 560/2005”.

5 Schedule amended

In paragraph 2 of the Schedule –

- (a) at the end of sub-paragraph (1)(b), the word “or” is deleted;
- (b) after sub-paragraph (1)(b), there is inserted the following clause –
- “(ba) on the authority of the Minister, to the Jersey Financial Services Commission, for the purpose of any of its functions, where the Minister believes that the exercise of such a function may assist in achieving compliance with Council Regulation No. 174/2005 or Council Regulation No. 560/2005;”.

6 Citation and commencement

This Order may be cited as the Community Provisions (Restrictive Measures – Côte d’Ivoire) (Amendment) (Jersey) Order 2011 and comes into force on the day after the day that it is made.
