COMMUNITY PROVISIONS (RESTRICTIVE MEASURES – SOMALIA) (AMENDMENT) (JERSEY) ORDER 2012

Coming into force

THE CHIEF MINISTER, in pursuance of Article 2 of the European Communities Legislation (Implementation) (Jersey) Law 1996, orders as follows –

1 Interpretation

In this Order "principal Order" means the Community Provisions (Restrictive Measures – Somalia) (Jersey) Order 2011.

2 Amendment of Article 1

In Article 1 of the principal Order, in paragraph (a) of the definition "Council Regulation", for the words "27 September 2011" there are substituted the words "17 July 2012".

3 Amendment of Article 2

In Article 2(4)(c) of the principal Order, for the words "Article 9(3)" there are substituted the words "Article 9(1)".

4 Insertion of Article 2A

After Article 2 of the principal Order there is inserted the following Article -

"2A Prohibition of import of charcoal

(1) A person must not –

- (a) import charcoal into Jersey if it
 - (i) originates in Somalia, or
 - (ii) has been exported from Somalia;

- (b) purchase charcoal which is located in or which originated in Somalia;
- (c) transport charcoal if it originates in Somalia, or is being exported from Somalia to any other country;
- (d) provide, directly or indirectly, financing, financial assistance, insurance or re-insurance related to any import, transport or purchase referred to in any of sub-paragraphs (a), (b) and (c); or
- (e) participate knowingly and intentionally, in activities whose object or effect is, directly or indirectly, to circumvent the prohibitions in any of sub-paragraphs (a), (b), (c) and (d).
- (2) This Article applies to a person
 - (a) who is in Jersey, including its airspace;
 - (b) who is on board any aircraft or any vessel under the jurisdiction of Jersey;
 - (c) that, being a legal person, entity or body, is incorporated or constituted under the law of Jersey;
 - (d) being a legal person, entity or body, in respect of any business done in whole or in part in Jersey.
 - (3) This Article does not apply to charcoal exported from Somalia prior to 22nd February 2012.
 - (4) For the purpose of this Article 'charcoal' has the meaning given by Council Regulation (EC) No. 147/2003 of 27 January 2003 concerning certain restrictive measures in respect of Somalia (OJ No. L 24/2, 29.1.2003)¹, as amended up to 18 July 2012.".

5 Amendment of Articles 3 and 4 and Schedule

- (1) In Article 3 of the principal Order, for the words "with the Council Regulation" there are substituted the words "with the Council Regulation or with Article 2A of this Order".
- (2) After Article 4(1)(b) of the principal Order, there is inserted the following sub-paragraph
 - "(ba) contravenes Article 2A of this Order;".
- (3) In paragraphs 1(1), 2(1)(c) and 2(1)(d) of the Schedule to the principal Order, for the words "with the Council Regulation" there are substituted the words "with the Council Regulation or with Article 2A of this Order".

6 Citation and commencement

This Order may be cited as the Community Provisions (Restrictive Measures – Somalia) (Amendment) (Jersey) Order 2012 and comes into force on the day after it is made.
